The Warren County Center of N.C. Cooperative Extension is pleased to offer a selection of agricultural equipment for use by Warren County residents at low cost. The specifics for each item are listed below. Procedures and policies are listed on the next page.

#### **PORTABLE CORRAL**

- \$25 per rental period
- Maximum **10 day** rental
- Maximum **5** rentals **per year**
- Must be picked up by user

## GRAIN DRILL/NO-TILL

- \$75 up to 10 acres, \$15 extra **per acre** over 10 acres
- Maximum **3 day** rental
- Maximum **5** rentals **per year**
- Must be picked up by user
  Requires 50 hp tractor
  minimum with rear hydraulics

### **SMALL RUMINANT WORKING CHUTE**

- \$15 per day
- Maximum **3 day** rental
- Must be picked up by user

### **BCS WALK BEHIND TRACTOR**

- \$20 per day
- Maximum **2 day** rental
- Maximum **5** rentals **per year**
- Must be delivered by Cooperative Extension

## PROCEDURES

- Reservations may be made in person or by telephone. Please contact well in advance of your desired date. You will be provided an email confirming the details of your reservation.
- You must sign the lease agreement prior to receiving the equipment (may be done on pickup day).
- Full payment is due upon return of the equipment.
- Equipment will be inspected for cleanliness and damages upon return. A cleaning fee of \$25 will be charged if equipment is returned dirty. Additional charges will accrue for damage to the equipment.
- Late return will be charged \$100 per day.
- If you are unable to pick up on the scheduled reservation date, you must call to make alternate arrangements. Otherwise, your reservation will be cancelled.
- Our equipment is for use only by Warren County farmers and landowners (21 and older), in Warren County.
- Equipment must be returned after each rental, i.e. it may not be moved from farmer to farmer.
- Delivery is not available, except for the BCS Walk Behind Tractor. For the rest of the equipment, an appropriate tow vehicle and hitch system must be used (e.g. a heavy duty pickup truck with frame mounted receiver hitch). User is responsible for verifying hitch size/type and equipment weight.
- Equipment must be picked up and dropped off between 9am and 4pm, Monday through Friday (excluding holidays).
- Instruction on proper use may be required, and must be arranged in advance.
- Every effort will be made to honor reservations, but last minute cancellations are possible due to breakdowns or other circumstances beyond our control.
